## Why Clusters?

### Advance Notification



Providers will be notified at the beginning of the year about all common topics, allowing them ample time to prepare and respond throughout the year.

### Coordinated Briefings



Providers can now plan the briefings early in the game, they can even combine the common topics and provide consolidated briefings.

### Flexibility



This program is intended to give tremendous amount of flexibility to providers to plan the responses to all the RFIs.

### Eliminate Redundancy



The program aims to also remove redundant efforts including overlapping questions.

# Process Details



## How will this work?

- 1 As part of cluster studies, AI and analytics series, seven studies will be launched at the same time in March 2025 <Please refer to the calendar in the previous page>.
- 2 Providers can assess the questionnaire content, scope of the studies and confirm participation accordingly.
- 3 The combined launch will give providers an advantage in proactively planning their response submissions and briefing calls. Kindly work with the designated project managers for planning.
- 4 The calendar provided outlines the timeframe for submitting RFIs and scheduling briefing calls.
- 5 Providers can opt for topic-specific briefings or choose to combine topics [Note: An advance notice is required for combined briefings].
- 6 Providers can offer more than one briefing but are limited to a maximum of three short sessions.
- 7 Providers can choose to submit the data anytime during the defined research phase. However, for each study, ISG will provide a cut-off date by which the data must be submitted to be eligible for evaluation [Note: Any data submitted after this cut-off date will not be considered for evaluation].
